

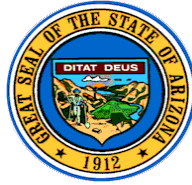
Registration Conditions:

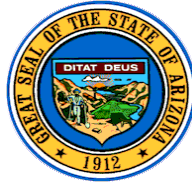
