ANIMAL HAZARDS PROGRAM/OCCUPATIONAL HEALTH PROCESS

The Animal Hazards Program (AHP) component of Occupational Health has fully transitioned to the RLSS User Dashboard. Labs may already be familiar with the User Dashboard as part of their other safety committee (hazards, laser, radiation, etc) and RLSS requirements.

The AWP will assist in adding staff to an Animal Hazards Program approval in RLSS User Dashboard as part of the protocol personnel process.

INSPECTION KUDOS & METRICS

IACUC semi-annual inspections of PI lab spaces were held earlier this month. From all of us at the AWP and the IACUC, kudos to our PIs, their lab managers and staff! We had very few inspection findings, and lab spaces are looking great! We are seeing a positive trend in recordkeeping, training, and documentation. We like what we see! Keep up the good work!

As a reminder, rooms used for surgery, satellite facilities, or USDA species need to be inspected at least every six months, while rooms used for other activities (imaging, euthanasia only, behavior testing, etc) only need to be inspected once a year.

EXPERIMENTAL DESIGN & LITERATURE ASSISTANCE

Two free resources are available to researchers to assist with experimental design and literature searches:

The [Experimental Design Assistant](#) (EDA) is a free resource from the [NC3Rs](#) that helps build a diagram representing your experimental plan, and offers

critique and bespoke feedback. The service does require registration, which is also free and easy. The tool itself is relatively easy to use and may help with designing your next project.

The USDA's Animal Welfare Information Center (AWIC) offers workshops on meeting the requirements of the Animal Welfare Act (AWA) as well as 3Rs alternatives literature search support – even for non-USDA animals.
