



## Export Control Determination (I-129 Checklist)

U.S. Citizenship and Immigration Services (USCIS) [Form I-129](#) Part 6 requires the **Responsible Party (RP)** supervising the foreign national employee/applicant to assess **export control issues** and **certify** whether a license is required for any technology or technical data to be released to a prospective **H-1B, H-1B1 (Chile & Singapore), L-1, or O-1A visa applicant** during their employment.

To determine if a license is needed, the RP should review [Federal Export Regulations](#), then answer the following questions. Please contact [Export Control](#) with any questions.
