9. Except as specifically provided otherwise by this registration, the registrant shall possess and use the laser(s) in accordance with the statements, representations and procedures contained in:
  - i. Letter of LSO Acknowledgment dated October 6, 2022, signed by Leon Harris, LSO.
10. Before every demonstration, the registrant shall supply the Bureau any and all: FDA Variances, FAA Variances, and show details.
11. Authorized nonionizing radiation users for this registration will be approved by Leon Harris, LSO. A current list of the approved operators will be maintained at the facility.
