

PI/PD/Co-PI/Co-I Minimum Employment Exception Request

The minimum level of University Employment required to be a Principal Investigator, Project Director, or Co-Principal Investigator at the University of Arizona is a 0.50 FTE as outlined on the PI Eligibility site. This exception request is reviewed on a case-by-case basis and should be noted that approval of exception requests will be rare.

This form is required when a tentative PI requests an allowance to serve as the PI, PD or Co-PI/Co-I on a project and whose employment with the University of Arizona is less than a 0.50 FTE.

A copy of this form must be submitted to SPS with your UAR proposal to ensure all appropriate entities have approved of the PI, PD or Co-PI/Co-I.
